MEDICATIONS

Please ensure that non-prescription medication brought into the Centre is clearly labeled with your <u>child's name, dosage and date of purchase in the original bottle given by</u> <u>the pharmacist</u>.

Just a reminder that Non-Prescription Medications cannot be administered on an "<u>AS</u> <u>NEEDED</u>" basis or for more than 2 consecutive days (the medication form needs to have complete information – symptoms, the exact dosage, the amount & time it needs to be administered).

If fever persists, we recommend that you consult with your child's doctor. Also, please ensure that the medication is taken home at the end of each use. We are unable to store any medication that is not ongoing.

Please apply sunscreen <u>before</u> coming to centre in the morning.

Your child's teacher will re-apply for afternoon play. We will assist with applying sunscreen to bare surfaces including the face and bare shoulders, arms, legs and feet 15- 30 minutes before outdoor activities.

Sunscreen **will not** be applied to any broken skin or if a skin reaction has been observed. Any skin reaction observed by staff will be reported promptly to the parent/guardian. It is the parent's responsibility to provide sunscreen with a minimum SPF of 30 or higher. Thank you! ©
